Members' Declarations of Interest

All members of London TravelWatch are, on appointment, required to make declarations of interest as to any shareholdings that might be regarded as creating a financial conflict with their membership of the Committee. (As of 11.08.09 no such declarations have been made in respect of any current members of the Committee)

From 1st January 2006 the Committee decided that members should declare other interests that could possibly be deemed to create a conflict with their membership of the Committee. Some such conflicts are likely to be more theoretical than real, but for the sake of open government and propriety they are listed below.

Very occasionally a member may find that he or she has a very specific conflict of interest relating to a personal interest in a proposal e.g. the location of a bus stop. In such circumstances the member concerned is required to make a declaration at the start of the meeting at which the item is being discussed.
